CHARGE: Upon approved credit in advance of order. Please send us (Attention Credit Manager) the completed Credit Application. Shipping charges will be added to all open account orders. For Purchase Orders, freight will be added. **CREDIT CARD:** Use your DiscoverCard, MasterCard, American Express or Visa; Shipping charges will be added. No minimum purchase amount required to use credit card. **C.O.D.:** We can ship immediately, there will be a C.O.D. fee added to the total order plus freight charges.

SPECIAL HANDLING: Freight charges must be prepaid for shipments outside the continental U.S.A. Shipments can be made provided insurance and freight regulations allow. C.O.D. orders shipped by air must have credit card payment for air charges prior to shipment.
